### Citizen Advisory/Action Committee Applications Desired

**SUMMARY:** The City of Borger seeks eleven (11) members of the public for the Citizen Committee to work towards Beautification efforts around the city. The committee will serve in an advisory capacity to the Borger City Council. Each member must live within the municipal boundary. The City is striving for and desires a diverse membership on the committee from all geographic areas of the city.

As a committee member, you will have several important responsibilities:

- collaborate on desired areas for beautification,
- assist in public education and outreach related to citywide cleanup efforts,
- work directly with city staff and council on proactive beautification efforts,
- attend the Committee meetings on a regular basis,
- assist staff in prioritization of problem areas,
- look at potential future beautification projects (landscaping, beautification projects, etc.),
- assess the current parks, potential park projects and number of parks in the municipality,
- assist in taking action on beautification efforts and coordination of communitywide service projects.

On Tuesday, March 13, 2018 at 6:00 p. m. in the City Council Room of City Hall, the Borger City Staff will conduct a public informational meeting about the committee and answer public questions.
